1. This Invitation for Tenders follows the General Procurement Notice for this Project which appeared in General Procurement Notice for this Project which appeared in *UNDB (Business on line)* Issue no. WB 1268-06/12 dated 6th June, 2012.
2. The United Republic of Tanzania has received a credit from the International Development Association and support from Department for International Development (DFID), United States Agency for International Development (USAID), Swedish International Development Cooperation Agency (Sida) and UN Agencies towards the cost of the Productive Social Safety Net Project and intends to apply part of the proceeds of this credit to cover eligible payments under contract to Supply Motor Vehicle Spare Parts.
3. The Tanzania Social Action Fund now invites sealed tenders from eligible Suppliers to Supply Motor Vehicle Spare Parts.
4. Tendering will be conducted through the *National Competitive Bidding* procedures specified in the Public Procurement Regulations, 2013 – Government Notice No. 446 as amended December 2016 and are open to all Tenderers as defined in the Regulations.
5. Interested eligible Tenders may obtain further information from and inspect the Tendering Documents at the office of the Secretary of the Tender Board, Tanzania Social Action Fund, P. O. Box 9381, Old Kilwa /Malindi Road - behind NSSF Waterfront Building, Main building, Third Floor, Room No. 20 from 8:00 to 16:00 on Mondays to Fridays inclusive except on public holidays.

A complete set of Tendering Document(s) in *English* and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 5 above and upon payment of a non-refundable fee of *Tanzanian Shillings Fifty Thousand only (TZS 50,000)*. Payment should be either by Cash, Banker's Draft, *direct deposit to CRDB Bank PCL, Vijana Branch, Dar es salaam, Tanzania Social Action Fund account number 01J1005174000* or Banker's Cheque, payable to *The Executive Director, Tanzania Social Action Fund*.
7. All tenders must be accompanied by a Bid Securing Declaration in the format provided in the Tendering Documents.
8. All tenders in one original plus *Three copies*, properly filled in, and enclosed in plain envelopes must be delivered to the *Executive Director, Tanzania Social Action Fund, Old Kilwa /Malindi Road, - behind NSSF Waterfront Building, P. O. Box 9381, Main Building, Third Floor, Room No. 20, Dar es salaam, Tanzania* at or before *10.00 hours East African time on 5th March, 2018*. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at the *TASAF Conference Room*.
9. Late Tenders, Portion of Tenders, Electronic Tenders, Tenders not received, Tenders not opened and not read out in public at the tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
